- Proof of identification (photo ID) for taxpayer and spouse
- Social Security cards for the taxpayer, spouse and dependents
- An <u>Individual Taxpayer Identification Number</u> (ITIN) assignment letter may be substituted for those who do not have a Social Security number
- Proof of foreign status, if applying for an ITIN
- Birth dates for the taxpayer, spouse and dependents
